

GENERAL MEDICAL SERVICE

We assess patients overall health through medical examinations, various diagnostic tests and high-tech procedures.

01.

MINOR SURGERIES

Ambulatory surgery is a type of surgical care that does not require significant intervention and hospitalization. Outpatient surgery or one-day surgery is not an alternative to inpatient treatment. rather. on contrary, it complements it. It contributes to the expansion of the volume of surgical care provided and has certain advantages.

Outpatient surgery at our clinic "KLINIK HARAMAIN" is an effective surgical treatment in a one-day treatment, guaranteed safety and comfort, convenient planning of all necessary interventions, allowing patients to maintain their usual quality of life and get results without stress and pain.

They work based on international standards and follow clinical guidelines accepted worldwide. EMERGENCY TREATMENT

"KLINIK HARAMAIN" is an independent emergency medical service that provides emergency specialized medical care around the clock, every day, seven days a week. We provides medical care in an emergency form, under the following conditions:

- Ol Caused by sudden acute illnesses.
- Carries out a statement of biological death during non-working hours.
- Accidents (trauma, traffic accidents, falls from a height, electric shock, drowning, hanging, injuries, bleeding, burns, foreign objects in the respiratory tract, poisoning and suicide attempts), loss of consciousness, with the development of an acute mental disorder.

CIRCUMCISION SERVICE

Circumcision is a minimally invasive surgery to remove the foreskin, that is, the part of the skin of the penis that covers the head of the penis. It can be performed both for medical and aesthetic, religious or hygienic reasons.

The intervention is carried out on an outpatient basis. The patient comes to the clinic on the day of the intervention.

The result of circumcision

As a result, the circumcision of the glans penis remains completely exposed. This will ensure its hygiene, reduces the incidence of inflammatory diseases, eliminates the likelihood of developing phimosis and paraphimosis.

Preparing for the operation

Before circumcision, the patient must undergo a set of examinations to assess the state of health, as well as to identify possible contraindications to the intervention. This includes a set of laboratory tests (general urine and blood tests, tests for infections, blood clotting, blood type).



HOME HEALTH CHECK -UP VISITS

Our doctors will professionally help patients keep abreast of their health status at home without the need to go to a medical center. The doctor will come to patient's home for a consultation, examination and possible diagnosis of the disease.

A doctor on call arrives at a certain time at the specified address for a consultation, which he will asks about the patient's complaints, collects information about the state of health and lifestyle, and conducts an examination. If necessary, the doctor conducts laboratory or instrumental diagnostics, which can be carried out at home.

If the patient has symptoms of a respiratory disease or there were risks of contracting a coronavirus infection, the doctor can take the patient's biological material for a PCR test, conduct a rapid antigen test or a rapid test for the detection of immunoglobulins M and G to confirm or refute the diagnosis of Covid- 19.

After consultation and diagnosis, the doctor will definitely issue an advisory opinion, which will indicate the diagnosis, prescribe dietary recommendations, further examination and treatment.

IMPLANON INSERTION AND REMOVAL & FAMILY PLANNING METHODS

IMPLANON is a gestagenic drug that can be used in the early postpartum period (after 6 weeks), during lactation.

A hormonal (progestogen-containing) subcutaneous implant is a method of long-term reversible contraception. Implanon is a highly effective, safe and acceptable method of contraception

Gynecologists of the **"KLINIK HARAMAIN"** were trained in the installation and removal of Implanon.

Indications for use

Implanon is used to protect against unwanted pregnancy for the next few years. The contraceptive effect is realized due to the progestogen, an analogue of the corpus luteum of the ovaries. It directly suppresses ovulation. A few days after the installation of "Implanon" under the skin, the desired effect is achieved.

The contraceptive should be replaced every 2-3 years. This period depends on the individual characteristics of the patient and the presence of excess weight.

ULTRASOUND DIAGNOSTIC

Most women, upon learning of their pregnancy, do everything they can to endure and give birth to a strong, healthy baby. After receiving a referral from a gynecologist for a fetal ultrasound, they begin to worry about how safe this procedure is for the unborn child. According to experts, ultrasound during pregnancy does not pose a risk to the mother's or the baby's health.

Our qualified specialists have extensive practical experience in the field of ultrasound diagnostics of pregnant women, which are safe for women's health. Doctors perform 2D, 3D, 4D ultrasound for pregnant women, using the capabilities of modern innovative expert-class equipment.

Diagnostic methods using our equipment allow pregnant women to:

- Get the highest quality and make the clearest picture. A wide range of special functions and scanning modes, ensures the study with maximum accuracy.
- The high level of image detail and the advanced technical functionality of the ultrasound machine help the doctor to obtain an accurate interpretation of the results and conduct an effective diagnosis of fetal development already in the early stages of pregnancy.
- Our equipment makes it possible to detect early defects and pathologies of fetal development. So, a 4D study helps to diagnose various malformations: heart, limbs, spine, face.

EXAMINATION OF PREGNANT WOMAN

During pregnancy, proper care of pregnant woman and the development of the fetus is especially important, with an assessment of factors that may affect the health of the fetus at birth and in the future. Pregnancy studies provide useful information from the beginning of pregnancy to the first days of a newborn's life, help to identify the most common risks and problems that occur during pregnancy.

At the Center, we carry out all the studies that may be needed during pregnancy: pregnancy test, all the necessary and recommended research for pregnant women, non-invasive prenatal examinations, coombs test for Rh conflict (rhesus) and a special set of studies for pregnant women.



X-RAY / RADIOGRAPHY

Radiography is a non-invasive and highly informative method for diagnosing diseases, based on the projection of x-rays onto a special film. At "KLINIK HARAMAIN", we use state-of-the-art X-ray equipment with low radiation exposure, so the examination is safe for patients of any age. It also provides high-resolution, high-contrast images, making it much easier for doctors to make a diagnosis. In our clinic, patients can make a high-quality X-ray examination at an affordable price in the shortest possible time.

Often, laboratory diagnostics reveals a pathological process in the body at a stage when there are no pronounced changes in organs and tissues, so the symptoms of the disease have not yet appeared. This is an element of the so-called pre-symptomatic diagnosis - a crucial component in detecting diseases in their early stages, when treatment is most effective.

Fomema is one and only agency to do pre screening medical health of non knowledge foreign workers to avoid unhealthy worker affect country economic and societies.

Foreign Workers must undergo the required medical examination at the chosen Doctor's clinic and X-ray centre before the doctor can submit the results to FOMEMA. They must undergo FOMEMA medical examinations every two years in order to ensure their health is in a good condition throughout their employment in Malaysia.
